Sexual Assault Prevention & Response (SAPR) Program Sexual Harassment/Assault Response & Prevention (SHARP) Program

Sexual Assault is the most underreported crime in our society and in the military. Department of Defense (DoD) prefers that sexual assault victims receive support and medical services as needed and offenders be held accountable for their crimes. However, the DoD recognizes that some victims willingly forego medical and support services to avoid command or law enforcement involvement. DoD's first priority is for victims to be protected, treated with dignity and respect, and to receive the medical treatment, care, and counseling that they deserve.

- Sexual assault is a crime and defined as: intentional sexual contact characterized by the use of force, threats, intimidation or abuse of authority or when the victim does not or cannot **consent**.

Per DoDI 6495.02 retaliation, ostracism, acts of cruelty, oppression and maltreatment are reportable to a SARC, VA, SVC, Commander or IG.
